UPA managers and inspection staff may be interested to see/compare submittal review comments for clarity and consistency. In CERS, the submittal comments are automatically sent to the business user.

To view or download submittal review comments begin with a Submittals search.

In the Submittals' section, select the UPA, the Submittal element and the submittal status, then search. You can also set a date range if desired. The results of the search will be displayed as shown. Export to Excel.
